



New Husky Checklist

NOW THAT YOU'RE A HUSKY:

The Admissions Office is here to assist in completing all required documents so you can have a smooth transition to the Husky Family. Be sure to complete each item below:



MENINGITIS VACCINE OR EXEMPTION FORM

Texas State Legislature enacted a law that states as of January 1, 2012, all new students who are under the age of 22 must show proof of meningococcal vaccination within the last 5 years. Your doctor's office or a local pharmacy may administer the vaccine. This includes residential and commuting students.

- An [HBU Meningitis Form](#) and proof of vaccination in the form of the shot record signed by the nurse or physician who administered the vaccine can be emailed to meningitis@hbu.edu.
- Exemption options that can be emailed to meningitis@hbu.edu:
 - Affidavit or certificate signed by a physician who is duly registered and licensed to practice in the US stating that in the physician's opinion, the vaccination would be injurious to the health and well-being of the student;
 - An affidavit signed by the student stating the student declines the vaccination for reasons of conscience, including religious belief. A [Conscientious Exemption form](#) from the Texas Department of State Health Services must be used.



FINAL TRANSCRIPTS

All offers of admission are tentative until the Office of Admissions receives your final high school and/or college or university transcripts. You must make arrangements with your school or university registrar to send your final transcripts no later than August 1.

- [High School Graduating Students](#): a final, official transcript with a valid high school graduation date.
- [College Transcripts](#): transcripts from all previous university or colleges attended with up to date course work.
 - Dual enrolled high school students must submit an official transcript from the college or university they attended.
 - If courses are showing "In Progress" or you never actually attended, a letter of non-attendance or withdraw must be submitted.



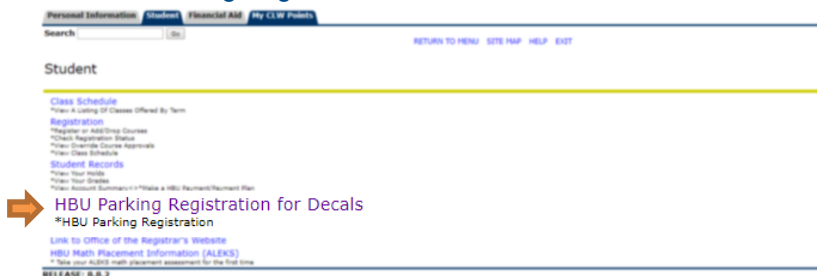
VEHICLE REGISTRATION OR VEHICLE WAIVER

Anyone who operates a motor vehicle on HBU's property must register that vehicle. All students are automatically assessed the \$150 parking permit fee. Students can waive their vehicle if they are not planning to operate a motor vehicle on HBU's campus.
